

# S.I.R.T. SPECIAL INVESTIGATIONS RESPONSE TEAM

On August 20th Newport Police requested SIRT assist with a hit and run collision between a vehicle and a bicycle on the 11th street bridge. The operator of the bicycle suffered fatal injuries and the vehicle did not stop after the collision. SIRT responded and reconstructed the collision scene. On August 25th Newport Police located the hit and run vehicle in North College Hill. SIRT assisted with drafting search warrants in order the seize the vehicle for its return to Kentucky. After returning the vehicle to Silver Grove Motors it was discovered the suspect had detailed the vehicle in order to remove any evidence. Once the vehicle was lifted up evidence was located on the frame (bicycle tire marks and paint flakes) which matched the bicycle that was run over.




