#### **MART**

The MART team had one call out for the month of May 15. The collision involved 2 vehicles on I-275 in Ft. Thomas's jurisdiction. Greg Haigis and Adam Peak responded to the call. The Faro was used to document the scene. The incident is under further investigation by the Ft. Thomas Police as the operator that caused the collision is believed to have been impaired.

#### Crime Scene Unit

The Crime Scene Unit had 3 callouts in the month of May. The first was in Wilder on May 1<sup>st</sup> involving a shooting that occurred in the 1400 block of Aspen Pines. Chris Boyd, Scott Nealy, Eric Schmidt, Jake Daley and Nick Hoffman responded for the CSU. No one was injured and the suspects fled the scene. The Faro was used to process the scene. The second scene was May 14<sup>th</sup> in Highland Heights to process the scene and collect evidence of an assault. A suspect has been charged in that incident. The third incident was May 24 in Ft. Thomas involving a suspicious death investigation. On May 5, the team held a Zoom meeting discussed in the meeting was the resignation of Robert Sewell from the team for personal matters. The team thanks Sewell for his service to the citizens of Campbell County.


