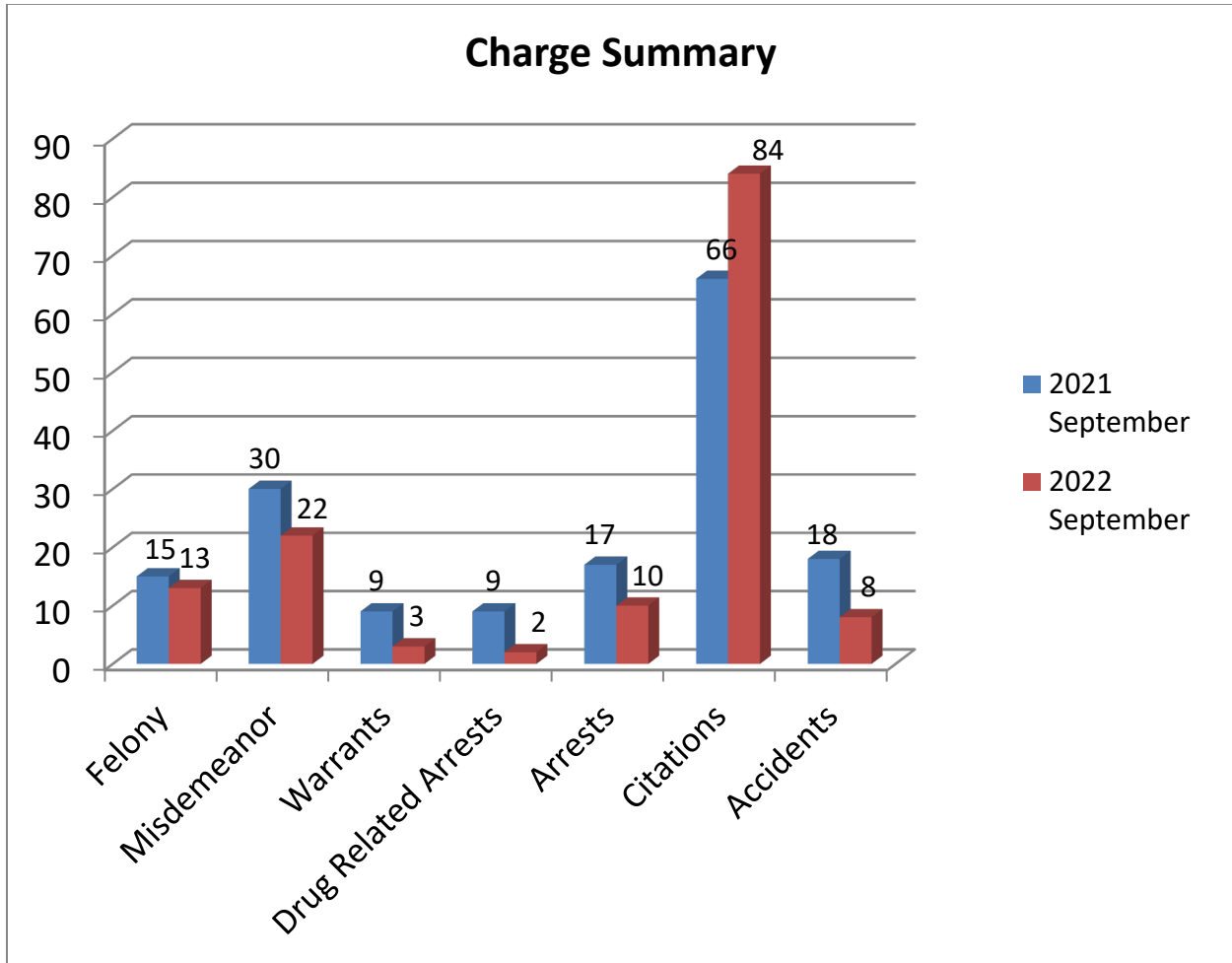

S.I.R.T. SPECIAL INVESTIGATIONS RESPONSE TEAM

On September 16th Dayton Police requested assistance from SIRT at an address on Ervin Terrace where an assault had occurred. SIRT responded to the scene where Dayton Police executed a search warrant. SIRT members documented the scene, conducted a search of the residence and collected evidence. Dayton Police are still investigating the incident and charges are pending.

On September 27th Wilder Police requested assistance from SIRT on Licking Pike near Bobby Mackey's where a head on collision had occurred. One of the drivers was pronounced deceased on the scene. SIRT members documented the scene, reconstructed the collision, and collected evidence. It was determined the deceased driver was responsible for the collision and there will not be any criminal charges.

On September 28th Wilder hosted collision reconstruction training. During the training officers trained only in crime scene processing were provided instructions for how they could assist on collision scenes.
